## CITY OF LEON REGULAR COUNCIL MEETING August 11, 2025 6:00 PM

Mayor Bob Frey called the meeting to order at 6:00 PM. Council members present were Jonathan Erb, Trevor Brown, Tonya Lindsey, and Lisa Moffett. Jerry Parsons was absent.

Also in attendance were Public Works Department Director Connor Christensen, Fire Chief Doug Moffett, Lonnie Cowden, Marcia Stephens, Loring Miller, and Tracee Knapp of Congressman Zach Nunn's Office.

Motion by T Lindsey seconded by T Brown to approve the agenda. All ayes, motion carried.

During the public comment time for items not on the agenda, Tracee Knapp spoke about the services that Congressman Nunn's office can provide to constituents. She said that the Congressman's office can assist people with the IRS, Social Security, Veterans Administration, or any issue someone might have with a federal agency.
