Motion by T Lindsey seconded by T Brown to approve the agenda. All ayes, motion carried.

Motion by J Parsons seconded by T Brown to approve the consent agenda. All ayes, motion carried.

Motion by J Parsons seconded by J Erb to approve the Leon Fire Department applying for grant funds to purchase a new water truck. All ayes, motion carried.

Motion by T Lindsey seconded by L Moffett to table signing a 28E Mutual Aid Agreement For Law Enforcement Services with Ringgold County. All ayes, motion carried.

Motion by T Brown seconded by J Erb to approve 2024-4: A RESOLUTION SETING A PUBLIC HEARING ON THE FY25 PROPOSED CITY OF LEON PROPERTY TAX LEVY RATE, setting the public hearing on April 8, 2024 at 6 pm. All ayes, motion carried.

Motion by J Parsons seconded by T Brown to approve reducing the large water bill for the Decatur County Fair, caused by a leak, by \$1,000. Additional discussion took place. No vote.

Motion by T Lindsey seconded by L Moffett to approve the appointment of Janis Eastin, Janet Chambers, and Lorina Cox to terms on the Library Board of Trustees to expire on 1/1/2030. All ayes, motion carried.
