REGULAR COUNCIL MEETING
August 8, 2022

Mayor Bob Frey called the meeting to order at 6:00 PM. Council members present were Tonya Lindsey, Jonathan Erb, Cody Cooper, Daniel Moffett, and Jerry Parsons.

Motion by J Erb seconded by C Cooper to approve the agenda. All ayes, motion carried.

Motion by J Parsons seconded by T Lindsey to approve the consent agenda. All ayes, motion carried.

Motion by J Parsons seconded by J Erb to approve the purchase of fire department radios from Racom for \$20,015.74 with money donated to the fire department. T Lindsey, J Parsons, C Cooper, and J Erb, ayes. D Moffett, abstain because he is a member of the fire department. Motion carried.

Motion by C Cooper seconded by J Erb to approve hiring Jacob Farlow at a wage of \$15.75/hr for a water department internship. All ayes, motion carried.

Motion by J Erb seconded by T Lindsey approve paying Curtis Architecture & Design \$15,100 for architectural work performed for the Upper Story Housing Grant at 200 N Main St. All ayes, motion carried.

Motion by C Cooper seconded by J Parsons to approve the purchase of a new server for city hall from Solutions for the quoted price of \$8,790.99. All ayes, motion carried.

Motion by J Erb seconded by C Cooper to approve the utilization of the remaining DEKKO grant funds by the Park & Pool Board to make improvements to the pool deck allowing for up to \$7,500 on concrete, up to \$5,000 on fencing, and up to \$7,500 on a shade structure. All ayes, motion carried.

Motion by T Lindsey seconded by J Erb to approve the purchase of a skid loader adapter for the streets department end loader from CL fabrication for \$1,975. All ayes, motion carried.

Motion by T Lindsey seconded by C Cooper to table any action regarding the replacement or rental of a street sweeper. All ayes, motion carried.

Motion by J Parsons seconded by J Erb approve RESOLUTION 2022-31: A RESOLUTION TRANSFERRING FUNDS FROM THE CEMETERY GENERAL FUND INTO THE CEMETERY PERTETUAL CARE FUND, transferring \$3,600. All ayes, motion carried.

Motion by J Parsons seconded by D Moffett to table any action on the suggested 7% fuel surcharge to Jim's Sanitation for solid waste collection until more details can be known. All ayes, motion carried.
